3. Video will be ready approximately 2-3 weeks after event date.

If WHEN TOMORROW FAILS Productions is unable to perform to the guidelines of this contract due to a fire, or other casualty, strike, act of terrorism, or other cause beyond the control of the parties, or if due to a When Tomorrow Fails Productions illness and if When Tomorrow Fails Productions is unable to provide a Videographer that is agreeable to the client, then all fees paid by the client will be returned in full, but When Tomorrow Fails Productions shall have no further liability with respect to the agreement. If When Tomorrow Fails Productions is unable to perform to the obligations in this contract for any other reason, When Tomorrow Fails Productions will not be liable for costs in excess of the amount the client has paid. This limitation of liability will also apply in the event that images are lost through camera malfunction or otherwise damaged without fault of the Videographer.
